Team Director Report: Frank

Added a couple of rules. Typed up for everyone. #3 changed minimally. Tournament fees are 1 heading now. Weekend team 1 day tournament = 100.00. Weekend 2 day = 150.00. Members look over. Moved entry fees moved up to entry rules. Pre tourney meeting, was in 2 places, combined and put together in 1 place. #10 methods, was in 2 different places and combined and put under 1 heading, "methods", changed the weigh in's to follow more along the lines of BASS for dead fish and short fish. "1/2 lb penalty for a dead fish and it will be weighed and part of the total weight. If the dead fish is the big fish, it cannot be weighed for big fish prize. Short fish is a 1lb penalty and it will NOT be included in your total weight. Short fish rules are State law which says you cannot have that short fish in your boat. Check in time, 1 lb penalty for each minutes late up to 15 minutes, after 15 minutes you are disqualified. Discussion on other rules. Plaques for Team Championship winners. Do we need a tie breaker rule? We need one and currently we do not have one. Do the same as the FMO. Weighing your big fish is the tie breaker. Entry fees will be going up this year to help pay for the scales. Team series: everyone needs to carry their insurance in their boat.
